## RENTAL TERMS AND CONDITIONS

This rental contract is nominative and personal to you. Under no circumstances may you transfer it or sub-let your rented accommodation. The lessee and all persons sharing the accommodation have the obligation to comply with the campsite rules available at the campsite reception.

#### 1/ BOOKING

Bookings become firm and definitive after we have approved them and received a deposit of 30% of the total amount of the stay  $+ a \in 4$  handling fee + the reservation contract, duly filled in and signed. The balance is payable on check-in for pitches and 1 month before your arrival date for accommodation rentals, failing which, we may cancel your booking and retain the deposit. Warning, the name on the invoice will be the same as that on the booking.

#### 2/ NUMBER OF PARTICIPANTS

We will accept no more than 8 people (young children included) for a rental unit for 8 people, 6 people (young children included) for a rental unit for 6 people, 2 people (young children included) for a rental unit for 4 people, 2 people (young children included) for a rental unit for 2 people, and no more than one vehicle per pitch, whatever the type of contract. Management reserves the right to refuse any additional persons on arrival, children and babies included.

Within the limit of the capacity of the chosen rental unit, any additional guests must be declared at the latest on the day of arrival and may lead to an increase in the rental cost. In conclusion, any inaccurate declaration or modification leading to a change in the total cost of the stay will render the contract null and void, unless the manager agrees to such changes, and no sums paid to the lessor will be reimbursed.

It is forbidden to pitch a tent outside a rented lodge, mobile home or chalet without the prior agreement of the manager.

Furthermore, we do not accept unaccompanied minors (under 18 years of age). Day visitors must pay an admission fee (cf. "visitors" in our list of rates).

#### 3/ DURATION OF STAY

For pitches: nightly rentals are possible. In July and August, check-in is from 12 noon and check-out by 12 noon.

For accommodation rentals: In July and August, the minimum duration is 1 week. Check-in is on Saturdays from 3 pm to 8 pm (please let us know if you expect to arrive later) and check-out is on Saturdays from 8 am to 10 am.

#### 4/ RATES

Our rates are inclusive of taxes, including 10% VAT. We reserve the right to adjust our rates in the event of a change to the tax or VAT rate.

A tourist tax is collected by the municipality of Gravelines and is not included in our rates. This tax will be payable at reception on your arrival.

#### 5/ PAYMENT

Warning, we will not accept a cheque payment on your day of arrival at the campsite. Any cheque payments must be made one month in advance.

#### 6/ SECURITY DEPOSIT

The rented accommodation comes with a detailed incoming inventory. The lessee must check this inventory on arrival and let reception know of any anomalies by noon on the following day. A security deposit of  $\epsilon$ 400 for accommodation units and  $\epsilon$ 60 for pitches will be requested on your arrival (to cover the rental and its state of cleanliness, as well as the entry pass and shower cards). These amounts will not be cashed and will be returned to you after the outgoing inventory check on your departure, with the amount corresponding to any observed damages or losses duly deducted. The lessee is responsible for cleaning the accommodation. Before departure, an outgoing inventory check of your accommodation and the immediate vicinity will be carried out to check they have been left in a perfect state of cleanliness. Failing which, you will be invoiced for  $\epsilon$ 85. In the event of departure outside the times indicated, your security deposit will be returned by post.

## 7/ MODIFICATION / CANCELLATION

Any modification to or cancellation of the contract must be requested from the management in writing (by email or registered mail). Please let us know if your arrival is delayed, to ensure we keep your accommodation for you. The manager reserves the right to re-allocate your pitch or accommodation if you have not arrived or informed us of any delay within 24 hours of the arrival date mentioned in the contract.

## Terms of cancellation:

- At least 30 days before your arrival date: the 30% deposit will not be refunded
- Less than 30 days before your arrival date: the amount corresponding to the full cost of your stay will be payable to the campsite.

No reimbursement will be made for a shorter stay due to late arrival and/or early departure.

### 8/ CANCELLATION AND INTERRUPTION INSURANCE - OPTIONAL

The campsite proposes cancellation insurance - Cost: 4% of the cost of the stay (£10 minimum). In the event of cancellation for a reason covered by the "Campez Couvert" policy, our partner, Gritchen Affinity, will reimburse all or part of the stay to clients having taken out such insurance. Details of cover: on request. In the event of cancellation or interruption of your stay, please inform the campsite and the insurer in writing and provide all the necessary information and appropriate documents.

## <u>9/ PETS</u>

Only one animal per pitch is authorised. Dogs of categories 1&2 are forbidden. Your pet's vaccination record must be up-to-date and presented along with the animal's registration number when you check in. Animals must be kept on a lead and must not under any circumstances be left alone on your pitch or in the accommodation unit. In the interest of others, please pick up your pet's excrement.

#### 10/ IMAGE RIGHTS

For advertising purposes, the manager of the Camping des Dunes campsite, or any other person appointed by the manager, may take photographs or videos of you and the other occupants of your rental unit. If you wish to refuse this, please tell us by writing to the management.

## 11/ PERSONAL DATA

By entering your personal information, you agree to be contacted for the management of your account/order, to receive our news and promotional offers.
